Rekatone Jaga is a programme that introduced by Rekatone to monitor the progress of the renovation project and act as a trusted third-party payment manager to collect, hold and disburse funds deposited by the Client with the Company to the Interior Professional through Rekatone mobile application.



## STEP 1 Opting for Rekatone Jaga

Rekatone's customer service personnel introduces the free complementary Rekatone Jaga service to the property owner via a phone call. Property owners have option to decide if they would like to subscribe to the service.

# **STEP 2 Discussing Project Details**

Property owners and their selected interior professional meet to set and agree to the terms of the renovation project, including the project deliverable (milestones) and the payment schedule which normally in contract, invoice, or quotation format.





# STEP 3 Milestones & Payment

In accordance with the contract submitted, at the start of every milestone, the property owner pays the agreed amount to Rekatone as per the payment schedule, and Rekatone will in turn pay out a portion of that amount to the interior professional, while holding the excess amount in escrow until all the deliverables in the milestone have been completed. Rekatone will only release payments after receiving request of claim from interior professional, and approval of payment release from property owner.

# STEP 4 Project Completion

Once the project has been completed and handed over to the property owner, the final sum in escrow held by Rekatone are paid to the interior professional. The retention sum of 5% will only be released after 3 months of retention period.

5% of retention will be released to Interior Professional after 3 months of project handed over.
